- Dog(s) come with a one year guarantee against hip and elbow dysplasia from date of birth.

- Above dog(s) is/are guaranteed by seller Von Falconer Canine Training (hereinafter known as "Von Falconer") to be healthy\*. \*A healthy animal is that which other members in the same profession selling the same type of animal would consider healthy. Von Falconer can not make any claims as to dog(s) ultimate size, coloring, look, weight, etc., as these factors are out of Von Falconer's control and also are influenced by outside variables. - If dog(s) has/have any health problems within 72 hours of Buyer receiving dog(s), or a longer period of time if noted here \_\_\_\_\_ (hours), dog(s) MUST be brought back immediately to Von Falconer's Veterinarian, Ty McConnell D.V.M. (hereinafter known as VET). VET will examine, treat, and cure Buyer's dog(s). All VET bills and boarding free of charge to Buyer. If dog(s) cannot be cured to full health and/or the dog(s) illness is due to a genetic defect, Von Falconer will REPLACE\*\* dog(s). If same sex and color etc. are not then available, Buyer will have to wait as long as it takes to get replacement dog(s) or opt to pick out different dog(s) at an earlier time when availability occurs.

- If dog(s) has any health problems and Buyer takes dog(s) to a different Veterinarian than VET, Von Falconer is not responsible for any payments or bills in any event to Buyer's chosen Veterinarian.

- As a German Shepherd Breeder and Dutch Shepherd Breeder for several years I gave a One year guarantee that said puppy was in good health and free of communicable diseases as far as Vet visit, and the seller agrees that in the event of the death of the puppy due to a birth defect (limited to one year) or disease contracted before the date of sale to replace the puppy at no charge. I believe so much in proper nutrition for growing puppies that I decided to double the guarantee (total of two years) if kept on Dr. Jane's Life Abundance system (food, supplements and treats) I added the above in the margin of my guarantee. After the recall, I decided not to give any guarantee at all unless said puppy was kept on the Life's Abundance system. I have never had anyone object to staying on the system and have proof by checking on my back office to see if they continued to order. This will provide the best for the Puppy or Dog, and will save the buyer in the long run.

#### WAIVER OF LIABILITY

I understand that any mishandling or improper care by myself or anyone appointed by me to care for, handle, or train \_\_\_\_\_ (name of dog) by any other than Von Falconer instructors, releases Von Falconer International, Marv Gangloff, Eric Falconer of Von Falconer K-9 at 750 Comstock Lane, Santa Cruz, or any other appointed Von Falconer International instructor from any liability. Also that I am required to attend 8 hours of training with the dog to learn proper handling. Any violation of the above conditions will terminate contract and guarantee will not be honored. I have read and understand the above and agree to the terms. No returns after 72 hours! After that point if you need to sell or relocate this dog it becomes your responsibility.
